Any name, term, symbol, slogan, or other design that serves to identify and set one company's or product apart from competitors in the market is considered a trademark. Having a patent is crucial since it can protect your creation. Any design, technique, or product that satisfies particular requirements in terms of uniqueness, usability, appropriateness, and practicality is protected. An invention is typically protected by a patent for a maximum of 20 years.
