- Protect the safety of the complainant by not divulging the person's identity and provide the
 mandatory relief by way of sanctioned leave or relaxation of attendance requirement or
 transfer to another department or supervisor as required during the pendency of complaint,
 or also provide for the transfer of the offender.
- Ensure that victims or witnesses are not victimised or discriminated against while dealing with complaints of sexual harassment.
- Ensure prohibition of retaliation or adverse action against a covered individual because the employee or student is engaged in protected activity.
